AFFIDAVIT IN REPLY

- I, JACKSON SSENYONGA C/O M/S Ojambo & Ojambo Advocates, Naigaga Complex, Plot 42, Luthuli Rise, Bugolobi, P.O. Box 21920, Kampala, affirm and state as follows:
 - 1. That I am a male adult of sound mind, Lead/Head pastor of the 1st Respondent and I affirm this affidavit on my own behalf and on behalf of the 1st Respondent.
 - 2. That I have perused the Notice of Motion of the Applicant dated 1st September 2022 together with the supporting affidavit of the Applicant of the same date and respond thereto as follows:
 - 3. That the contents of the Notice of Motion application and the supporting affidavit are denied and the same shall be put to strict proof.
 - 4. That neither the 1st Respondent nor I are employers of the 3rd to 6th Respondents as alleged in para 3 of the affidavit of the Applicant.
 - 5. That in reply to para 4 & 5 & 6 of the affidavit of the Applicant, I state that the Applicant is unknown to me, and is not and has never been a member of the 1st Respondent church. Neither are the 3rd and 4th Respondents members of the 1st Respondent church. I challenge the Applicant to prove his alleged membership of the church since all members of the church are issued membership certificates.
 - 6. That it is only the 5th and 6th Respondents who volunteer once in a while as usher and security help respectively on some days of large gatherings but have never been employed by the 1st Respondent or myself.

- 7. That in response to para 6 of the affidavit in support, I categorically state that there is no chapatti maker at the 1st Respondent church as alleged by the Applicant and further affirm that no one is allowed to sell any items or food at the church.
- 8. That in further response to para 6 of the affidavit in support I affirm that the 4th Respondent is not a member of the 1st Respondent's security team and the 6th Respondent is not the head of security in the 1st Respondent church and is not my personal body guard as alleged. I challenge the Applicant to furnish proof thereof.
- 9. That in response to para 9 & 10 of the affidavit of the Applicant I state that I never recorded or made the alleged statement attached as Annexture 'C' and affirm and or state that the signature on that statement is not my signature and that the statement is consequently a forgery and or fabrication. That I accordingly categorically deny the allegations in para 9 of the affidavit of the Applicant.
- 10. That I further categorically deny the allegations in para 10 of the affidavit of the Applicant and the same be subjected to strict proof thereof.
- 11. That the contents of para 11, 12, 13, 14, 15, 16, 17, 18, 19 are unknown to the 1st Respondent and I and were in any event, if at all, not committed by the 1st Respondent and I or with our authority.
- 12. That the claims in this application are alleged crimes which are personal in nature and as such the 1st Applicant and I cannot be held vicariously liable for criminal actions of the 3rd to 6th Respondents if at all.
- 13. That I have read through the judgment against the 3rd to 6th Respondents attached as annexure "B" to the application which judgment reveals that the 6th Respondent completely was not at the scene and was not stated to have robbed or to have beaten the Applicant and was only talked about at the police station.
- 14. That I have further upon being served with this application learnt that 5th and 6th Respondents have appealed against the said Judgment and conviction in the Court of Appeal.

15. That para 20 is denied and I state that the application is malicious, frivolous and baseless and ought to be dismissed with costs.

16. That whatever is stated herein is true to the best of my knowledge and belief.
